Note: Water savings data reflects water use three months in the past. Also, "gallons per capita" is the standard of "measure" for tracking water conservation efforts. The State has determined our water use per person per day is 47 gallons by 2025, and 42 gallons by 2030. Keep saving, Joshua Tree!

# Liquid Soap vs. Bar Soap: You Decide...

When it comes to cleaning up--we certainly all have our preferences. But did you know that using liquid soap can actually help save water?

Here's how: most bar soaps leave a "scum" or residue when they encounter water with healthy minerals in it (like our water). However, liquid soap actually behaves differently in most cases, offering a clean rinsing effect which minimizes the additional use of water (and often cleaning agents) to scour tubs and shower stalls clean.

So, if you don't have a preference one way or the other, consider liquid soap and remember: every drop counts!

# CLASS IS IN SESSION: JBWD's Outdoor Classroom

Ms. Campbell's Palm Vista Elementary School's 5th graders came to learn about desert gardening involving water conservation in late April.

46 Students met tortoise hatchlings while learning about native wildlife needs and their adaptations to an arid environment, how to start seedlings using scant amounts of water, how nature moves different seed types across the desert, soil variations, beneficial bugs, natual plant defense mechanisms--and much more.

Students rotated in groups amongst the five themed gardens on a perfect spring day! Our heartfelt thanks to our energetic, dedicated, and awesome volunteer instructors!

# IN CASE YOU MISSED IT...

The new water rates went into effect March 1, 2023, and will be reflected in your May billing statement. The new rate increase voted on is currently set at 9%.

Also, as of May 1st, JBWD will no longer absorb the convenience fee for credit card payments. The cost to our Community Owned Water District has now exceeded over \$40,000 per year for this convenience that not everyone uses.

To pay without fees, consider cash (in person), a check (mail or use our drop box out front in the District parking lot) or your bank's auto-pay as viable options.



# CURIOUS MINDS WANT TO KNOW:

Often, at our Farmers' Market booth or on social media, we get good questions that others may be asking. Here's more of a sample:

Q: This question has resurfaced several times since the recent rate increase and bares sharing again: "Do District employees, Board Members or Consultants receive a water discount?"



A: NO. The only discounts any of the above could posssibly qualify for are the same ones afforded to our entire customer base. Specifically, the United Way of the Desert's Low Income Assistance Program, which has been increased to \$100 per qualifying person per year, is the only discount that we are legally able to offer at this time.



# YOUR LEADERSHIP IN ACTION

Recent Board Action Items of Note:

In accordance with government law, the JBWD Board of Directors opted to use the appointment process to fill the Division 2 Board Vacancy created by the passing of Director Barbara Delph. The Board voted 3-1 in favor of candidate David Fick at the last Board meeting.

#### Background:

The District had three options for replacing a vacant Board seat:

- 1) They could wait for an election if it was within the stipulated time frame for a major election (which it was not) or pay as much as \$100,000 to hold a separate election;
- 2) They could use the appointment process, which must be achieved within 60 days of the date of the Board seat vacancy; or
- 3) Do nothing and allow San Bernardino County to appoint a new Director to the Board.

Two highly qualified candidates from Division 2 applied to represent Joshua Tree residents and were interviewed in a public forum at the April 19th regular Board meeting. Joshua Basin Water District thanks everyone who participated in this difficult but

# CAPITAL IMPROVEMENT AND REPLACEMENT PROGRAM (C.I.R.P.)

HISTORIC USES OF:

May Watering Schedule: Before 9:00 AM and

#### after 6:00 PM

Due to warmer weather, it is best to water during the early morning and late evening hours to reduce evaporation.

# THIS MONTH IN YOUR DESERT-SMART LANDSCAPE:

Rising temperatures causes changes in plants.


- As weather heats up, change watering schedule from mid-day to early morning or evening to minimize loss through evaporation
- Maintain a good mulch of organic matter covering garden soil throughout the summer to hold moisture
- Remove ("deadhead") spent flowers unless you want to collect seeds (to simulate repeat blooming)

# 'Smokey'

## **Smokey Coast Rosemary History**

Also refered to as "Coast Rosemary, Coastal Rosemary, or Native Rosemary", this particular evergreen shrub is a type of mint native to Australia. It however does not share similar aromas to that of rosemary or mint plants.

No apparent historic use has been noted for this plant, and it is notable to <u>not</u> confuse it with the health and edible properties standard to mint or rosemary plants.
