State Water Resources Control Board-Case No. 34-2015-80001850).
- 11. GENERAL MANAGER REPORT GM Sauer reported on the following:
  - Well 14 Rehab is on schedule with good progress being made to bring it back online by June 6, 2017.
  - Recharge began on May 15, 2017 and is now complete with 584 AF.
  - Victoria Fuller's Celebration of Life was held on May 17, 2017 at the Demonstration Garden with overwhelming support from all of the organizations that Victoria was affiliated with attending.
  - Chrome 6 Update No additional guidance from the SWRCB. Contacts have indicated maybe two weeks before the State figures out next steps.
  - CVWD is proposing to State, on May 30, 2017, a full-scale pilot to treat Chrome 6 with Stannous and put it directly into a water system to test a bench level finding. A well at 20ppb treated and exposed to chlorine is only oxidizing 20 percent back to Chrome 6.
