WELL 14 REHABILITATION PROPOSAL

Seth Zielke, Director of Water Resources and Operations gave the report. For the Well 14 Rehabilitation Layne Christensen Company would go forward with all of the work necessary except for the motor. The Brithany company would repair the motor and JBWD is awaiting a bid proposal, which would not exceed \$100,000.

10. UPDATE ON NEXTERA SOLAR PROJECT

GM Sauer gave the report. GM Sauer met with San Bernardino County regarding the NextEra Solar Project and their application with the County to drill a well. The County Environmental Health supervisor indicated that the well permit would likely be approved if NextEra met state and county codes for water quality and well construction requirements. The County Environmental Health supervisor also stated that JBWD would be advised of any well permit applications within the service area (other than NextEra's). County Land Use Planning provided Initial Study for review, and JBWD is providing a comment to the Initial Study with regards that JBWD has issued a Will Serve letter to NextEra, however the acre feet estimate for the project is 86 AF instead of the original estimate of 49 AF due to recalculating water estimates stated in the Initial Study. The Board received for information only.

Public Comment:

Al Marquez, Sunfair Community, Joshua Tree: Mr. Marquez is asking whether NextEra is required to do an Environmental Impact Report, and suggested that the area is a wildlife corridor for special status species such as Burrowing Owl and Desert Tortoise. Mr. Marquez also suggested that the property is not owned by NextEra.

Gary Biggs, Joshua Tree: Mr. Biggs states the residents in the area near the proposed solar facility do not want solar facilities in the residential area or so close to the National Park.

Rob Bernheimer, Attorney representing NextEra thanked the Board for their cooperation. Mr. Bernheimer stated that NextEra needed a more definitive timeframe for obtaining water, which is why they are exploring the option of drilling a well, and stated that their first preference would be to obtain water from the JBWD, and to put more water in the aquifer than NextEra takes out. In response to comment by Al Marquez, NextEra is following CEQA guidelines and an Environmental Assessment is currently being conducted.

Director Unger asked who is the owner of the property?

Counselor Bernheimer stated that NextEra is currently under contract to purchase the property, and all applications filed with the JBWD and San Bernardino County are with the owner's consent. Upon approval with the County, escrow will close and NextEra will own the property (not lease).

Director Johnson asked about the reasoning for the particular location.

This location was chosen because the County did a solar ordinance that placed a preference on previously disturbed land and the county ordinance has a distance requirement from Joshua Tree National Park of two miles. Bernheimer states environmental studies of this area show low habitat quality for species of concern whereas some other properties had higher concerns.

Director Johnson asked what advantage does NextEra see by installing a solar facility in the community?

NextEra would like to bring benefit to the community. Bernheimer stated they were paying the property owner a substantial amount of money.

Directors Luckman and Fuller inquired about the timeline with regard to power purchase agreements.

Counselor Bernheimer stated they are still under deadline to begin construction according to power purchase agreements which expire near the end of the year.

Jess Melin spoke regarding the placement of the solar facility and why they have chosen to locate the solar facility in Joshua Tree, including the location of the existing transmission infrastructure.

12. FLEET VEHICLE REPLACEMENT

Seth Zielke, Director of Water Resources and Operations gave the report. The scope of the work requires appropriate vehicles, and thus additional vehicles are required for safety reasons as well, and to provide for better use of staff time.

Public Comment:

Al Marquez, Sunfair area, Joshua Tree: Mr. Marquez suggested JBWD should be looking into cost cutting and suggested JBWD should be replaced after 10-12 years instead of 7-8 years. Mr. Marquez stated the \$100,000 + should be going towards pipe replacement instead of vehicles at this time.
