TOPIC: COMPUTER SOFTWARE FOR FIELD SERVICES

RECOMMENDATION: That the Board take the following action:

- Authorize purchase of Computer Maintenance and Management System Software through the California Rural Water Association from SEMS Technology for no cost; and
- 2) Authorize training and integration services at a cost of \$5,000; and
- 3) Authorize annual maintenance fee of 6,880 for four years which provides one year free

All for a total of \$11,880.

Alternatively, authorize \$6,960 which will install the program but provide for only one year's maintenance.

**ANALYSIS:** 

The current budget anticipates purchasing computer management and maintenance system software for the field services that will enable scheduling, tracking of various state reports, and numerous other services that will be shown in a demonstration at the Board meeting.

The budget amount was \$10,000 for the software only. The California Rural Water Association (CRWA), of which JBWD is a member, received a grant to develop the SEMS software specific to small water districts, at a cost exceeding \$50,000. That software is now available to us at no cost.

The \$11,880 will provide onsite implementation, training, and integration with the GIS system, as well as four years of maintenance, with the fourth year free to CRWA members.

Incode, the District's financial software, is affiliated with a firm that offers a similar system (but we believe not as suited) at a cost of about \$29,000 plus \$4,000 annual maintenance, in addition to installation, training, and other costs.

Purchase of this software will provide a very valuable tool to the field crew and to field administrative personnel. A web demonstration will be presented at the special meeting at 6:30pm.
